

CONTEST RULES FOR VANCOUVER INTERNATIONAL MARATHON SOCIETY

THE PRIZE

ELIGIBILITY REQUIREMENTS

6. To be eligible to win a prize, contest participants must post a picture with the hashtag #runvan on Facebook or Instagram. Participants must 'like' the Vancouver International Marathon Society Facebook page and follow us on instagram at @runvanCanada.
7. In order to be declared a winner, the entrant must:
 - a) Respond to the prize notification via. facebook/instagram private message within 48 hours of transmission (if any selected entrant cannot be reached within 48 hours from the time of initial contact, an alternative entry may be selected)
 - b) Sign the Society's standard declaration which states, among other things, that he/she:
 - I. Has read, understands and complies with the Contest rules;
 - II. Releases and discharges Society and its parents, subsidiaries and affiliates, the suppliers of prizes or services related to the Contest, and their respective advertising, promotion and production agencies and other agents or representatives
 - III. Consents to the announcement of the winner's name and the use by or on behalf of Society of the winner's name, address, photograph, likeness, voice or statements for advertising and promotional purposes without any further compensation to the winner.
8. Should the declared winner not agree to the declaration above within 5 days of being



selected, the applicable prize will be automatically forfeited and another entrant will be selected by random draw.

9. The entrant must collect the prize at one (1) of the specified locations within 30 days of notification.
10. The chances of winning depend upon the number of eligible entries received.
11. An Entrant can only win the contest once (1) in a calendar year. (July 2016 – Dec 2016)

DISCLAIMER AND LIABILITY EXCLUSION

12. The Society, the suppliers of prizes or services related to the Contest, and their respective advertising, promotion and production agencies and other agents or representatives will not, under any circumstances, be responsible for, or liable to any Contest entrant or any other person for:
 - a) any erroneous, lost, damaged, late, incomplete, misdirected, falsified, deleted, defective, or altered Contest entries, regardless of the cause;
 - b) any failure for any reason whatsoever of the selected entrant to receive a prize notification email;
 - c) any changes in email addresses or email address assignments after Contest entry forms are submitted;
 - d) any computer, online, telephone, or technical malfunctions or errors that may occur, regardless of the cause; or
